## REQUIREMENTS FOR THE FORMATTING

**Font:** Times New Roman 14 pt., an interval – 1,5 lines, fields – 20 mm.

**Masthead:** the author's the first and the last name, degree and status, work place, e-mail and address should be on the right side of the top corner.

**The topic of the report (article):** in the middle of the page (all capital letters, a bold type).

**The summary:** about 5 lines.

**Key words:** before the basis text.

**The conference working languages:** Ukrainian, Russian, English.

**Size:** 2-3 pages for the theses and not less than 12 pages for the article.

A requirement for participation in the conference is a **presentation** of the report, which may also be accompanied by the video or audio version of the report.
